

2. Remove (2) tow loop bolts and tow loop. Return tow loop and bolts to owner. **Note:** The first photo shows the tow loop covered by the underbody panel, the second shows the underbody panel removed.



INSTALLATION WALKTHROUGH:

3. Raise hitch into position and secure using M12-1.25 x 30mm and 1/2" conical toothed washers. Note: For ease of installation raise the passenger side into position first.





4. Torque all M12 hardware to 72 ft-lbs. Reinstall underbody panel removed in Step (1).



INSTALLATION STEPS

- 1. Remove the driver side underbody panel by removing (5) fasteners. Panel and fasteners will be reinstalled later.
- 2. Remove (2) tow loop bolts and tow loop. Return tow loop and bolts to owner.
- 3. Raise hitch into position and secure using M12-1.25 x 30mm and 1/2" conical toothed washers. (See Weldnut Cleaning Detail)

 Note: For ease of installation raise the passenger side into position first.
- 4. Torque all M12 hardware to 72 ft-lbs.
- 5. Reinstall underbody panel removed in Step (1).
