

- 2. Remove spare tire. Using hitch as template, mark tire well for 3/8" fasteners. Remove hitch and drill tire well at marks. Reinstall hitch as shown.
- 3. Torque all 3/8" hardware to 45 lb.-ft.
- 4. Use silicone sealant to seal hardware hardware installed through tire well.
- 5. Reinstall license plate, spare tire and fascia / bracket bolts removed in Step 1. PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
