AFTERMARKET PRODUCTS AND YOUR VEHICLE'S WARRANTY

Many of our customers ask, "Will your product void my vehicle manufacturer's warranty?" While the answer is straightforward from a legal standpoint, we also want to educate our customers (and after-market consumers) on some industry realities and offer some common sense precautions to minimize your risk.

Consumers of aftermarket products are protected by The Federal Magnusson-Moss Warranty Act. The Act states that if something breaks on your car and you take it in for warranty repair, the dealer must honor your warranty unless they can prove that whatever modifications you have added to your car actually caused the problem. Please keep in mind that towing in anything higher than level two and hard driving in levels four and five are not recommended.

While as a consumer, you have strong legal protection with regards to your vehicle's warranty, there is also a practical reality that different automotive manufacturers and dealers have greatly varying views on aftermarket products, in particular those that produce horsepower, such as performance enhancement chips, modified intake manifolds, or aftermarket exhaust systems. There are dealers and manufacturers out there that will use the presence of a horsepower upgrade to void your vehicle's warranty. They will do this regardless of whose product you are using. Any aftermarket company that does not acknowledge this is misleading you.

The bottom line is that while the law protects the consumer and provides for enforcement of the warranty, it is very difficult for most people to hire an attorney and fight a voided warranty. Edge recommends that you always disconnect and remove your module and monitor when you take your vehicle to a dealer for warranty work in order not to interfere with Diagnostic equipment.

Module Installation

1. The *Power Edge EZ Module* can mount on the flat black plastic fuse box cover located on the driver's side fender. Adhere the module using the supplied velcro, allowing enough harness movement for removal of the cover.

Harness Connector

Your EZ module may be equipped with a harness that can be disconnected at the EZ module itself (See figure 1A). It is important to make sure that your EZ module is always connected to the harness when the wiring harness is connected to the truck, otherwise the truck may not run properly, or may trip engine "codes."

MAP Connection

2. Connect the supplied MAP sensor wiring harness to the supplied main wiring harness in the engine compartment. Disconnect the stock wiring harness at the boost sensor located on top of the intake manifold. Plug the supplied MAP sensor connector into the stock engine boost sensor and the stock engine wiring harness connector into the supplied MAP sensor connector.



Fuel Pressure Sensor Connection

3. Connect the supplied pressure sensor wiring harness to the supplied main wiring harness in the engine compartment.

Disconnect the stock wiring harness at the sensor located on the main fuel rail on the driver's side towards the rear of the engine. Plug the supplied pressure sensor connector into the stock pressure sensor on the engine and the stock engine wiring harness connector into the supplied pressure sensor connector.



Boost Elbow Installation (Optional)

The installation of the brass elbow permits turbo boost pressures of greater than 20 psi without the wastegate opening. The *Power Edge EZ Module* will operate equally well with or without this installed.

- 4. Using the 5/16" socket, loosen the two clamps securing the air induction hose to the air filter housing and the turbo inlet. Remove the hose and set it aside.
- 5. Using the pliers, remove the crimp style clamp from the hose on the brass fitting located on the now exposed lower front side of the turbocharger. Remove the hose from the brass fitting and dispose of the crimp style clamp.



6. Using the 7/16" wrench, unscrew the stock brass fitting out of the turbocharger housing. Using the 7/16" wrench, install the supplied brass fitting, tighten-be careful not to over-tighten. Slip the supplied hose clamp onto the stock hose, install the stock hose onto the supplied brass fitting and tighten the hose clamp with the ½" socket. Reinstall the stock air hose onto the air filter housing and turbocharger inlet. Using the 5/16" socket, tighten both clamps securely.

7. Using the 7/16 deep socket tighten all of the intercooler hose clamps on the air intake.



Final Inspection and Operation


- 8. Recheck all connections, fittings and fasteners for a properly secure installation.
- 9. Using the supplied wire ties, secure the wiring harness from possible damage.

Fueling Adjustment


The *Power Edge EZ Module* features 4 different levels of fueling. The *Power Edge EZ Module* is set default to level 3.


- 1. To change settings remove the front panel by using an allen wrench to remove the two screws.
- 2. Below the cover the 3 jumper settings on the right side are used for the power level adjustment.
- 3. This jumper can be removed and repositioned in any of the locations to achieve the desired response as shown below.


Note: Jumper settings on the left side of the board are for storage only.
