BEFORE STARTING:

Ensure that the engine is cold and has not been run for a minimum of 2 hours prior to install.

INSTALLATION:

1. Remove your iNTECH cold air intake in order to access the back side of the driver's side headlight.
2. From the back of the driver's side headlight, carefully press inward on each of the three plastic clips on the headlight cap, and then push the headlight cap out (**Figure 1**).

3. Firmly press the air duct to install into the iNTECH housing as shown (Figure 2).

4. Reinstall the housing assembly making certain the auxiliary air duct is aligned with the headlight hole and covers the headlight tunnel (**Figure 3**).
5. Reinstall the tube and remaining intake components previously removed.
6. Make certain all connections are tightened as laid out in the 223-12 / 223-13 INTECH instruction sheet.

NOTE: This item will not fit models equipped with R/T SCAT Pack.
