BEFORE STARTING

Your vehicle must be raised a minimum of 36 inches. A floor hoist is ideal. If no hoist is available, we strongly urge the use of axle stands as a safety measure.

<u>CAUTION!</u> Your car should not be supported on a bumper jack. We recommend welding all pipe slip joints. If no welding equipment is available at the time of the installation, use the furnished clamps to secure the pipes, until they can be welded.

NOTE: This Y-Pipe is designed to fit with Hooker Headers, P/N 2850HKR, 2850-1HKR, 2851HKR or 2851-1HKR ONLY!

INSTALLATION PROCEDURE – PLEASE READ CAREFULLY

- 1. Disconnect the battery.
- 2. Install Hooker Header P/N 2850HKR or 2851HKR per instructions included with it.
- 3. Remove the factory Y-Pipe assembly.
- 4. Bolt the Y-section of the 16785HKR or 16786HKR assembly to the 2850HKR/2851HKR headers at the 3-bolt collector flanges.
- 5. Bolt the extension flange at the ball socket end to the intermediate pipe, using the supplied hardware.
- 6. Tighten all bolts at this time.
- 7. Reconnect the battery.
- 8. When finished, give your vehicle a test drive, checking carefully for any new noises. After several days of driving, re-tighten all the bolts.
