



# INSTALLATION INSTRUCTIONS

## PRO-BILLET LATE MODEL FORD DISTRIBUTORS

5.0L, 1986-1993, PN 8456

5.0L, 1994-1995, PN 8455

351W (non-roller cam), PN 8453

351W (with hydraulic roller cam), PN 8452

351W (with hydraulic roller cam), 1994-1995, PN 8451

### Parts Included:

1 - Distributor

1 - O-Ring

1 - Gear Lubricant

**WARNING:** During installation disconnect the battery cables. When disconnecting the battery, always remove negative cable first and install it last.

### GEAR INFORMATION

The Pro-Billet PN 8451, PN 8452, PN 8455 and PN 8456 Distributors are designed as a direct replacement for Ford EFI High Output engines and are equipped with a steel gear for the hydraulic roller camshaft.

The PN 8453 model is a replacement for 351W engines with a TFI Ignition module and is supplied with an iron gear (non-roller camshaft).

### REMOVAL

1. Remove the existing distributor cap without disconnecting any spark plug wires.

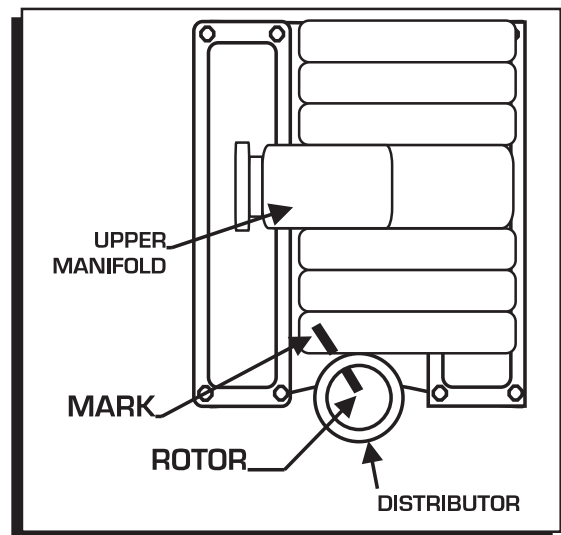


Figure 1 Marking the Distributor Location.

2. With the cap off, turn the engine over until the rotor is aimed at a fixed point on the engine or firewall. Note this position by making a mark (Figure 1).
3. Place the distributor cap back on and note which plug wire the rotor is pointing at. Mark the spark plug wires and remove the cap.
4. Disconnect the connector from the distributor's ignition module.
5. Loosen the distributor hold-down clamp and slide it out of the way.
6. Lift the distributor out of the engine. Note that the rotor rotates as you lift it out. This is due to the helical cut gear and should be taken into consideration when installing the new distributor.

# INSTALLATION INSTRUCTIONS

## INSTALLATION

1. Remove the cap from the MSD distributor and install the new o-ring.
2. Apply a liberal amount of the supplied break-in lubricant to the distributor gear.
3. Install the distributor making sure that the rotor comes to rest at the fixed mark. If the distributor will not fully seat you may need to rotate the oil pump shaft.
4. With the rotor in the correct position and the distributor fully seated, install the distributor clamp and tighten it.
5. Connect the wiring harness to the ignition module.
6. Install the distributor cap and install the spark plug wires one at a time to ensure correct location. The firing order of the Ford Mustang 5.0L and the 351W is: 1-3-7-2-6-5-4-8.  
**Note:** This firing order only applies to high output 5.0L engines with a hydraulic roller camshaft.
7. You will need to check the ignition timing to get it to exact specifications. To check the timing you need to disconnect the Spout connector. Follow the recommended procedure which should be outlined on the Emission Specification Decal in the engine compartment.

### Service

In case of malfunction, this MSD component will be repaired free of charge according to the terms of the warranty. When returning MSD components for service, Proof of Purchase must be supplied for warranty verification. After the warranty period has expired, repair service is charged based on a minimum and maximum charge.

When returning the unit for repair, leave all wires at the length in which you have them installed. Be sure to include a detailed account of any problems experienced, and what components and accessories are installed on the vehicle.

The repaired unit will be returned as soon as possible after receipt, COD for any charges. (Ground shipping is covered by warranty). All units are returned regular UPS unless otherwise noted. ### Limited Warranty
