1. The roll pan requires cutting for this hitch to be installed. Obtain vehicle owner approval before beginning install.
2. Prior to installation, loosen spare tire and remove the ground wire that is bolted to the bottom of the driver side frame. (Not all models will have the ground wire located here.) After installation, relocate the ground wire to the .281 " square hole in the frame bracket using the 1/4-20 carriage bolt and the nylon lock nut provided.

## Installation Steps:

1. Loosely fasten the hitch to the frame as shown.
2. Torque all $1 / 2-13$ fasteners to 110 lb . ft.; Torque all $1 / 4-20$ fasteners to 12 lb . ft.
3. For drawbar installation cut the roll pan in the license plate area to provide access.

Note: The license plate must be repositioned when the draw bar is installed.
