## **INSTALLATION STEPS**

MAY NEED DRILLING OR HOLE ENLARGEMENT

1. Raise hitch into position. Align rear holes in side plates with 1 1/8" round holes in rear of frame. On long bed models, forward most holes will line up with holes 16" forward of rear holes in frame.

(SHORT BED CONFIGURATION SHOWN)

- 2. Install hardware, as shown above. <u>Note</u>: 9/16" hardware should be located in vehicles rearmost mounting locations with CM-SP74 spacers. CM-SP1 spacers are used in middle holes and CM-SP6 spacers are used in forward most holes.
- 3. Torque all 1/2" hardware to 110 ft-lbs and all 9/16" hardware to 150 ft-lbs.
