

## NATIONWIDE EXTENDED TIRE PROTECTION PLAN

### WHAT IS COVERED BY THE EXTENDED TIRE PROTECTION PLAN

The Extended Tire Protection plan is valid for <u>5-years from date of</u> <u>purchase</u> on tires that become unserviceable or damaged from a cut, snag, bruise, impact, sidewall damage, or puncture caused by a road hazard. Ground shipping charges to recover (if necessary) and replace tire(s), is covered. Tires will be prorated after 15 months according to tread wear used. Product will be replaced at the discretion of Coker Tire with the same product or in some cases a similar product, if the same product is not available. If you want the Extended Tire Protection plan on the replacement tire, you must purchase it.

## HOW TO PURCHASE EXTENDED TIRE PROTECTION PLAN

Extended Tire Protection Plans:

- Tires priced up to \$250.00, cost \$10.00 per tire
- Tires priced up to \$251.00 to \$299.00, cost \$20.00 per tire
- Tires priced \$350.00 and up are \$25.00 per tire

\*One plan per tire must be purchased.

The Extended Tire Protection plan covers any tire meeting the conditions set forth that becomes unserviceable or incurs damage due to an impact, road debris, pothole or other damage caused by a road hazard and not listed under exclusions. Product will be repaired or replaced at the discretion of Coker Tire with the same product or in some cases a similar product, if the same product in not available. As part of this, Coker Tire will pay ground shipping charges to recover and replace tire(s) if necessary. Not all claims require returning the damaged tire. This is not a warranty. Coker Tire makes no representations that your tire cannot fail or become unserviceable. Coker Tire's only liability is to repair or replace the product. Coker Tire is not responsible for mounting, balancing or any other incidental or consequential damages.
