

1987-2006 JEEP WRANGLER GEN 3 HEMI ENGINE SWAP Y-PIPE BH2354

Installation Instructions



Thank you for choosing to use Hooker Blackheart products on your 1987-2006 Jeep Wrangler Gen 3 Hemi engine swap project. This Y-pipe is part of the most comprehensively designed engine swap system available for installing a Chrysler Gen 3 Hemi engine into a Jeep YJ, or TJ/LJ application. It has been specifically designed to connect directly to the Hooker Blackheart headers and exhaust systems that are also part of this swap system. This Y-pipe is designed to be used on Jeep Wrangler vehicles that are built/assembled for off-road/racing use only. Hemi swapped Jeep Wrangler vehicles that are built/assembled for street use should be equipped with factory exhaust manifolds and a Y-pipe containing catalytic converters that are approved for use in this engine swap application.

PRE-INSTALLATION CONSIDERATIONS:

Check that the hardware package includes the following:

IMPORTANT! Position and support your vehicle on a suitable surface. USE CAUTION AND WORK ONLY ON A LEVEL SURFACE USING JACKS AND JACK STANDS OF SUFFICIENT CAPACITY TO LIFT AND SUPPORT YOUR VEHICLE. NEVER WORK UNDER A VEHICLE SUPPORTED BY A FLOOR OR BUMPER JACK. Use of a two-post under arm lift or four-post drive-on lift will considerably reduce the time and effort required to complete the installation. MAKE SURE LIFT LOCKS ARE ENGAGED BEFORE WORKING UNDER THE VEHICLE.

INSTALLATION:

NOTES: This Y-pipe is designed specifically for use with the stock Gen 3 Hemi truck oil pan.

This Y-pipe will accommodate installation in both a stock inclination angle drivetrain configuration and a belly-tuck drivetrain installation without encountering interference with the vehicle frame or body tub floor.

These instructions have been written under the assumption that you have already installed a Gen 3 Hemi engine and 545RFE transmission into your vehicle, on the stock skid plate, using Hooker Blackheart engine and transmission mounting components and have also installed Hooker Blackheart Jeep Wrangler Hemi engine swap headers onto the engine per their instructions.

- 1. Raise and support the vehicle.
- Loosen the bolts attaching the headers to the cylinder heads if they have been fully tightened already to allow slight movement of both header assemblies.
- 3. Place the supplied 2.5" band clamp over the Y-pipe slip connector and then insert the supplied short driver's side Y-pipe leg into the slip connector.
- 4. Lift the Y-pipe assembly up and position its V-band flanges against the mating V-band flanges of the Hooker Blackheart Gen 3 Hemi headers.

- 5. Install the two 2.5" V-band clamps (supplied with the Hooker Blackheart Gen 3 Hemi headers) over and onto the V-band flange connections (use a helper if needed to perform this task). Tighten the nuts on the clamps alternately, until all the slack has been removed from the V-band connections, but still allow slight rotational movement in each of them.
- 6. Fully tighten all the header bolts.
- 7. If you are installing a Hooker Blackheart Jeep Wrangler YJ, or TJ/LJ engine swap exhaust system, continue on to the instructions contained within their packaging. If you are building your own exhaust system to connect to this Y-pipe, then tighten the V-band clamps after ensuring that suitable clearance is provided between the Y-pipe collector and the right side frame rail, and also between the Y-pipe collector and the transmission case.
- 8. Finally, tighten the band clamp on the Y-pipe slip connector under the engine oil pan.

Hooker BlackHeart Exhaust Limited Lifetime Warranty 304 Stainless Steel Exhaust Products

Hooker BLACKHEART 304 stainless steel exhaust products are covered by a limited lifetime warranty that covers certain defects in workmanship and materials.

Who is covered?

This warranty covers the original purchaser of Hooker BLACKHEART 304 stainless steel exhaust products in the United States and Canada.

What is covered and for how long?

Holley Performance Products Inc. ("Holley") warrants that Hooker BLACKHEART 304 stainless steel exhaust products will be free from defects in material and workmanship for the life of the product on the original car on which it was installed. Blemishes, marring of appearance, discoloration, internal rust, or surface rust due to weather, road hazards, lack of maintenance, or extremes of heat or cold are not considered defects under this Limited Lifetime Warranty. Holley warrants moving parts such as valves and actuators for three years. All claimed warranty products must have a return goods authorization (RGA) number and shipped to Holley at the buyer's expense. The returned product must be accompanied with a copy of the original purchase receipt and the original purchaser's contact information.

What will Holley do?

If there is a defect in material or workmanship, Holley will choose either to repair the defective part or replace it with a comparable, new part, without charge for the repair or the replacement product.

Purchaser's remedies under this Limited Lifetime Warranty are strictly limited to the repair or replacement of the defective product. You must pay the cost of shipping the product back to Holley and for any labor or other costs, including any additional parts, associated with removing the allegedly defective part and with the installation of the repaired or replacement part.

What is NOT covered?

This warranty does not cover Hooker BLACKHEART stainless steel products that have been installed on any commercial or racing vehicle or that have been damaged due to misuse, abuse, neglect, or accident, such as having been modified or altered; improperly installed, adjusted or repaired; welded; exposed to corrosion, corrosive materials, other contaminants; or used in applications other than those recommended by Hooker on our website (www.holley.com).

How do I start the warranty claim process?

To initiate the return process under this Limited Lifetime Warranty, please contact our customer service team immediately at 800-638-0032 and hit customer service option or email at holleyorders@holley.com for complete Hooker BLACKHEART product return instructions and to request a Return Goods Authorization (RGA) Number. Please be prepared to return the allegedly defective product to Holley, along with a copy of the original dated purchase receipt. Holley reserves the right to reject a warranty claim if you cannot establish date of purchase. Final warranty determination is at the sole discretion of Holley.

Should I use Header Wraps?

If you choose to use header wraps, you will void your Warranty. Header wraps cause fatigue in the primary tubes and create fractures in the metal.

What other conditions and exclusions apply?

This warranty does not provide compensation for loss of time, loss of use of vehicle, labor cost, cost of additional parts, shipping, inconvenience or other consequential or incidental damage. Some states do not allow the exclusion or limitation of incidental or consequential damages, so these limitations or exclusions may not apply to you.

Holley's maximum liability under this Limited Lifetime Warranty shall not exceed the original cost of the product to the consumer. This Limited Warranty gives you specific legal rights and you may also have other rights which vary under state or provincial laws.

This Limited Warranty is exclusive and in lieu of all others, whether oral or written and whether express or implied. Any implied warranties, including implied warranties of merchantability and fitness for a specific purpose are hereby disclaimed.
