

Custom Spark Plug Wire Set Installation Instructions

To avoid the possibility of placing the plug wires on the distributor cap incorrectly, REMOVE ONE WIRE AT A TIME. Start with the longest wire and replace it with the longest new wire. Then replace the next longest, and so on, until ending with the shortest wire.

- 1. Remove the longest existing spark plug wire from the vehicle.
- 2. Select the longest spark plug wire from the Flame-Thrower wire set.
- 3. Push the spark plug wire boot onto the spark plug and route the new wire back through the wire looms to the distributor cap.
- 4. Push the distributor terminal firmly into the distributor cap and slide the distributor boot onto the distributor cap.
- 5. Repeat steps 3 through 11 for each additional wire from the longest to the shortest ending with the coil wire.

CAUTION...

Make sure that there is adequate clearance between all spark plug wires and the exhaust manifolds. Damaged wires due to inadequate clearance are not covered under warranty.
