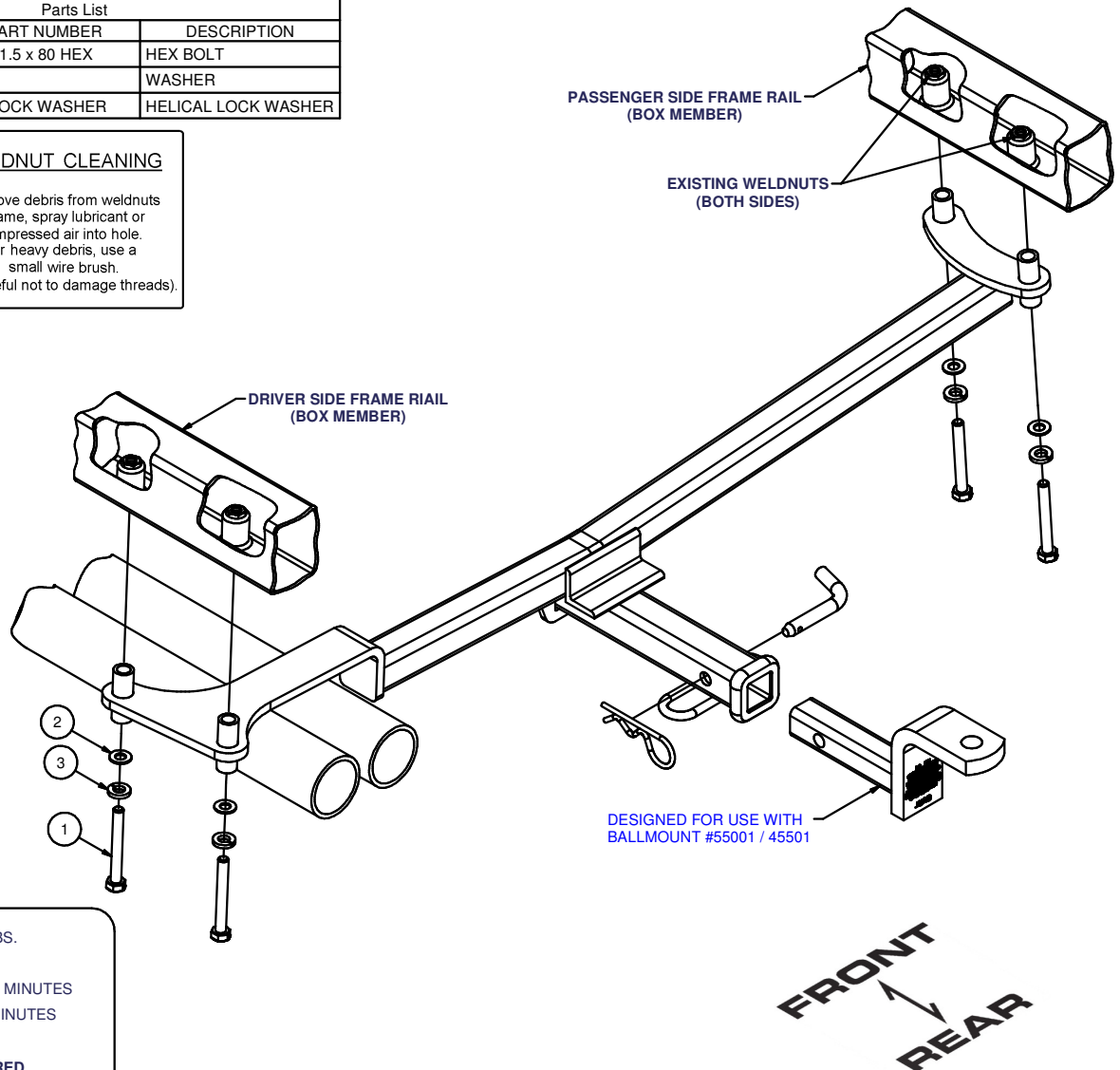
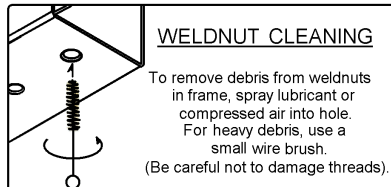

INSTALLATION STEPS

1. Under the rear of the car, locate the frame rails (box members) at the left and right side of the car with two recessed 10mm bolts in each one. Remove both bumper screws in each frame rail; the hitch will bolt at these points.
2. Position the hitch on the car as shown. Work the hitch above the exhaust system on the driver's side. Disconnect the rear exhaust hangers temporarily if necessary. Using fasteners provided with the hitch, mount the hitch at these points securing the hitch and the bumper to the car chassis. Be certain to use washers as shown in the diagram.
3. Torque all 10mm fasteners to 45 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
