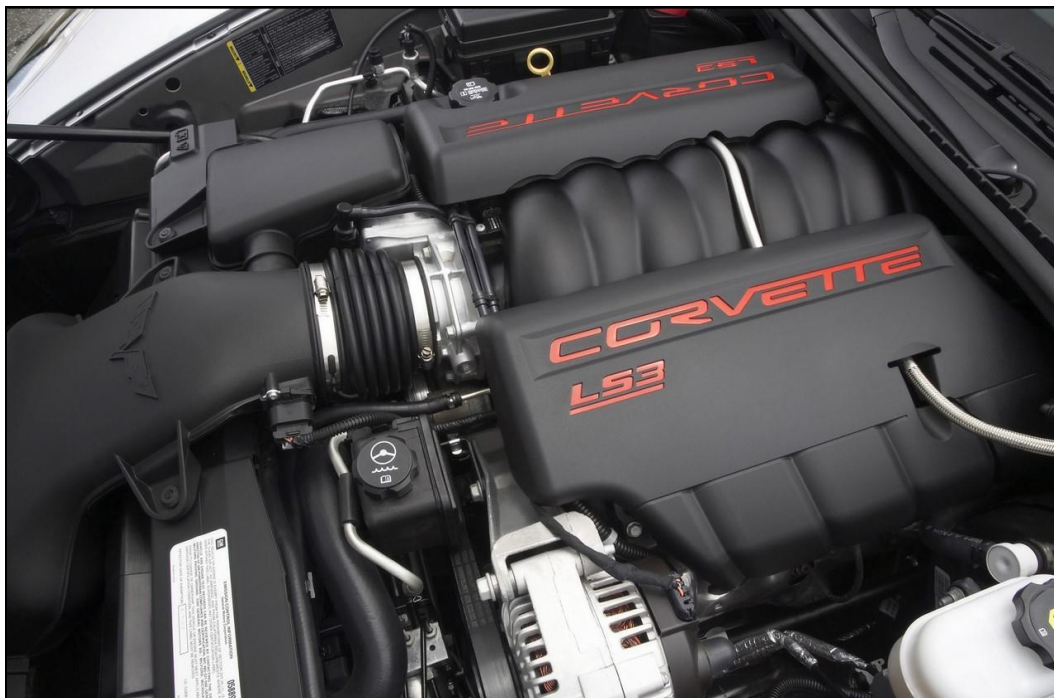

Installation Instructions

BEFORE STARTING:

Ensure that the engine is cold and has not been run for a minimum of 2 hours prior to install.

INSTALLATION:

1. If existing ABS cover is installed, remove the (x2) M6 screws and (x2) flat washers (**Figure 1**).

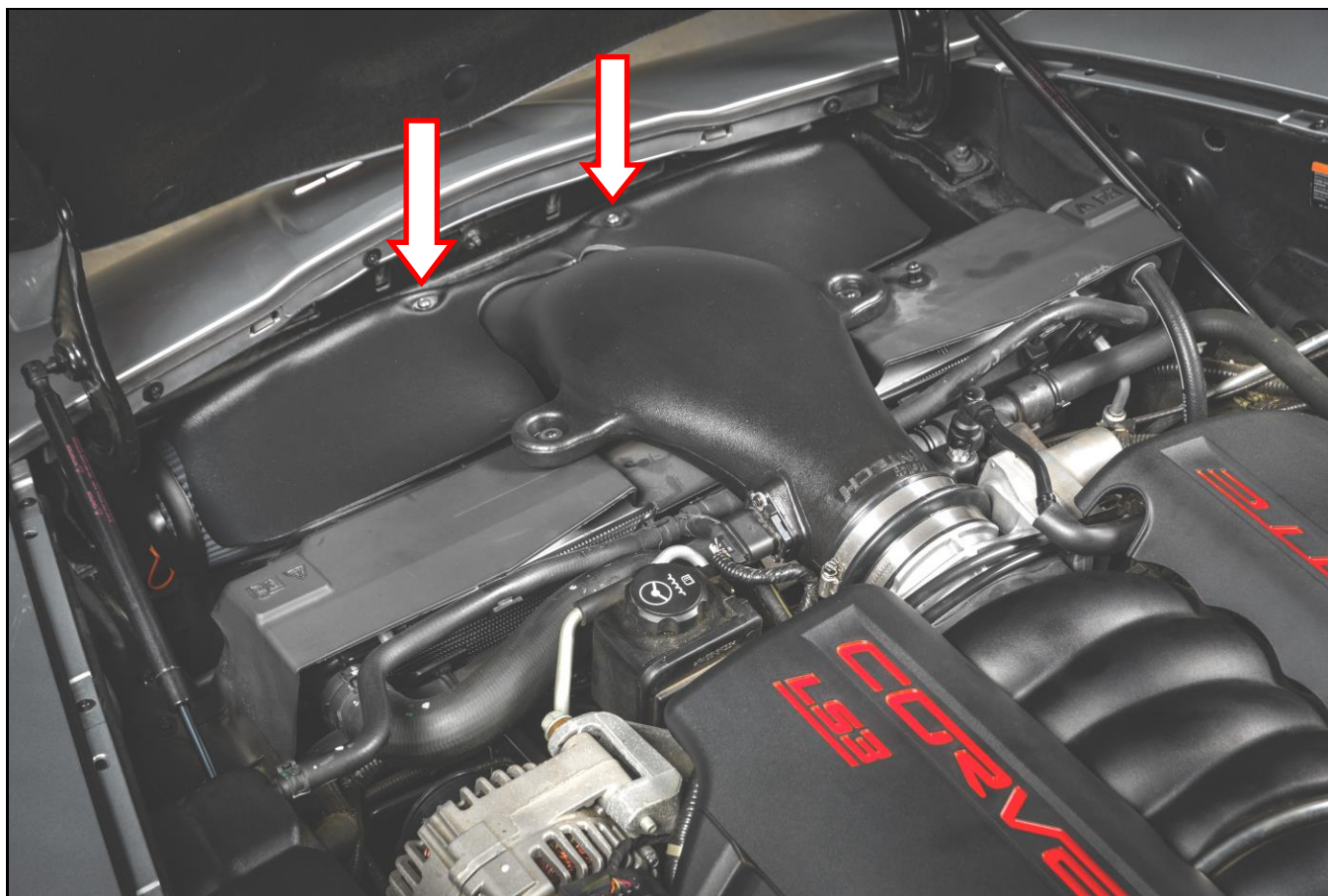

2. Carefully lower the iNTECH carbon fiber cover into the location shown (**Figure 2**).
3. Align the holes with the cover and the intake tube and secure using either the previously removed hardware or use the (x2) provided M6 screws and (x2) washers to secure the cover in place.

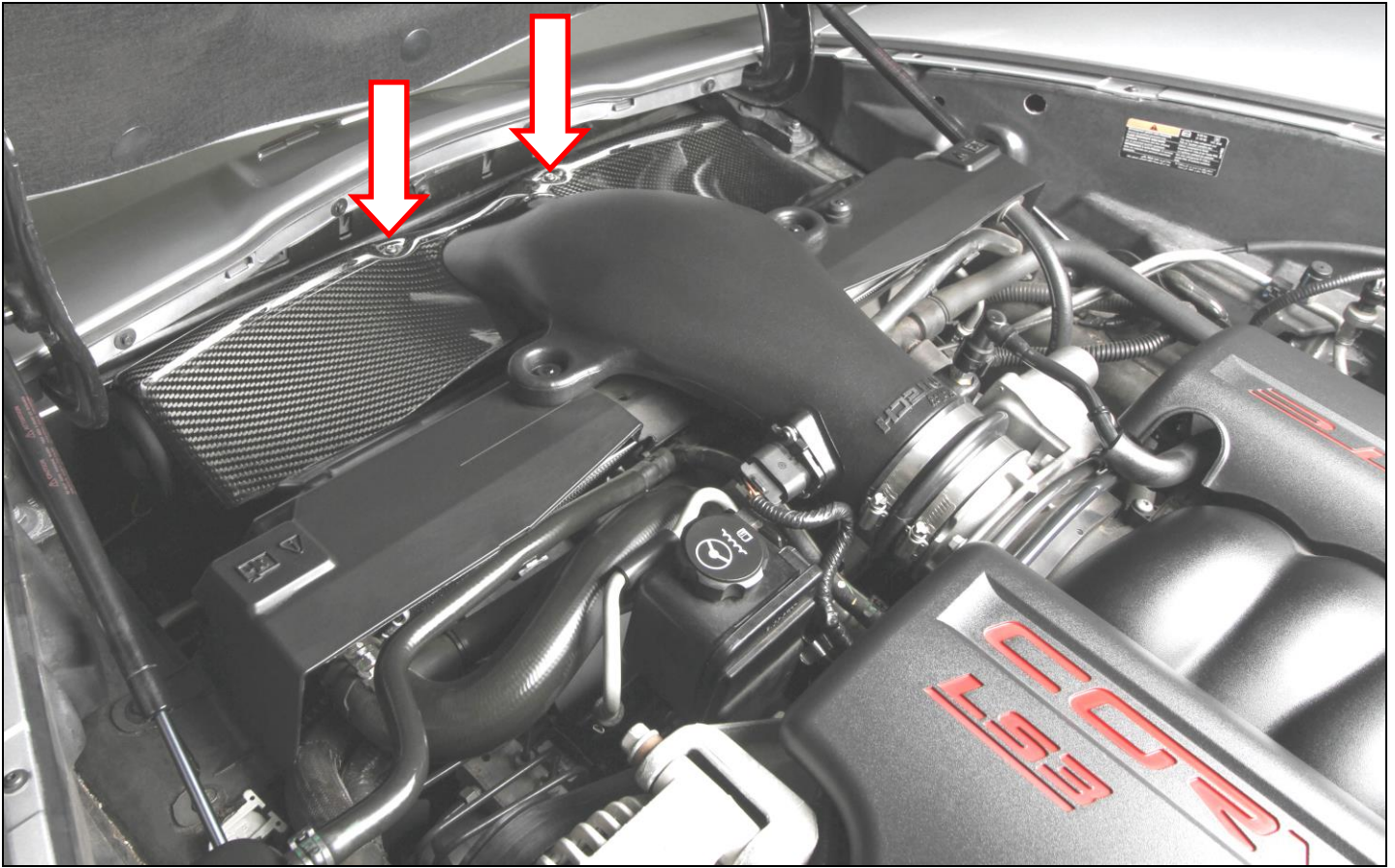

- ***NOTE: Be careful not to over tighten the screws.
- ***NOTE: Use only a mild detergent and a microfiber cloth if cleaning the cover is necessary.
- ***NOTE: After 150 miles, re-check and tighten all nuts, bolts, clamps, and fittings.
